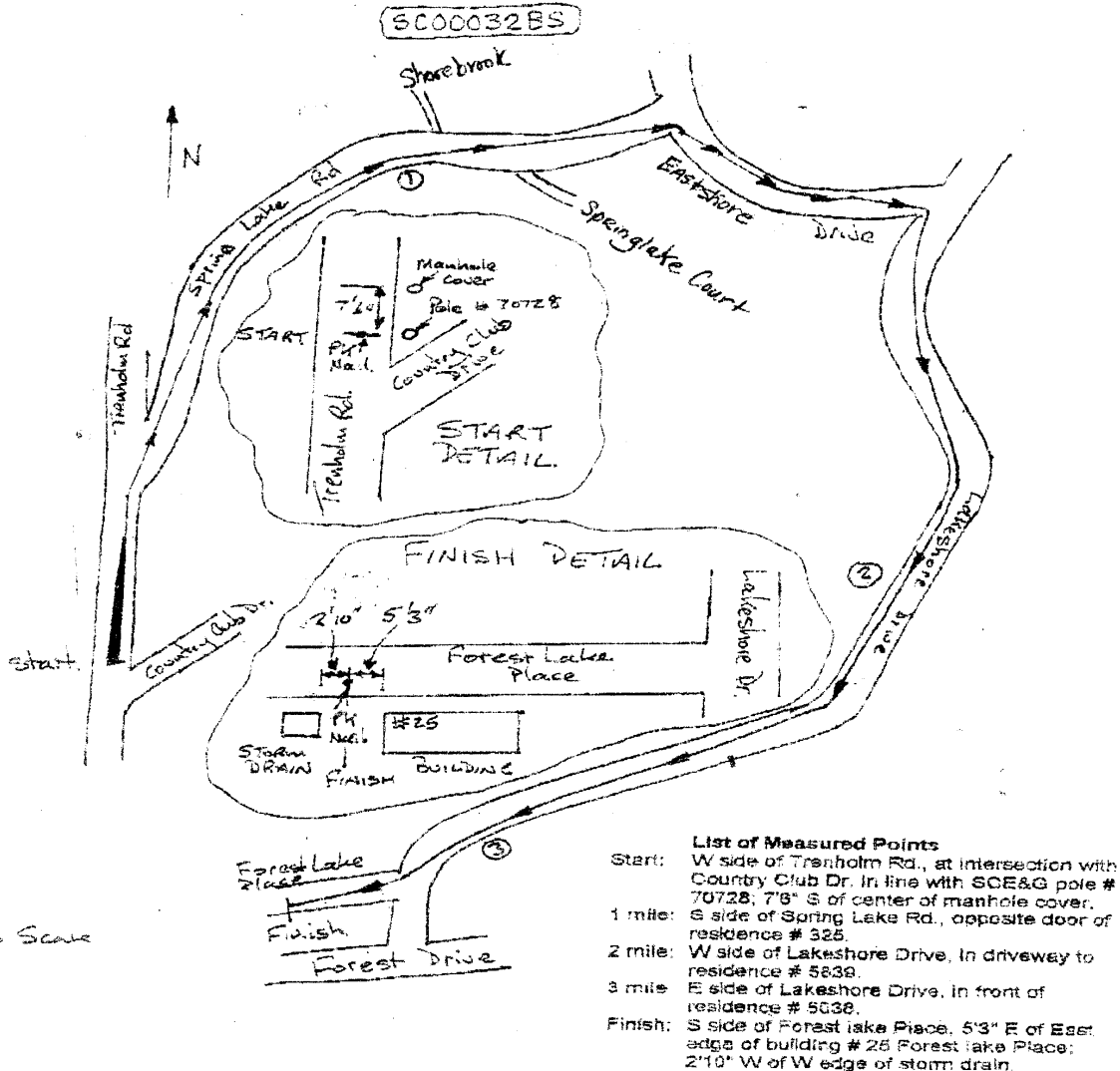

- Start: W side of Trenholm Rd., at intersection with Country Club Dr. in line with SCE&G pole # 70728; 7'6" S of center of manhole cover.
 - 1 mile: S side of Spring Lake Rd., opposite door of residence # 325.
 - 2 mile: W side of Lakeshore Drive. In driveway to residence # 5832.
 - 3 mile: E side of Lakeshore Drive. In front of residence # 5038.
 - Finish: S side of Forest Lake Place, 5'3" E of East edge of building # 25 Forest Lake Place; 2'10" W of W edge of storm drain.
